REGULATION SUMMER CAMP 2025 SIENA FC

The 2025 Summer Camps are organised by Siena F.C. (hereinafter referred to as the 'Organising Club') with its head office in Viale dei Mille, no. 3 in Siena, at the Stadio Comunale 'Artemio Franchi'.

1) Purpose

The aim of the Siena FC Summer Camp is to stimulate all children in a pure and healthy environment and to have fun.

The groups will be divided into age groups as close as possible and the training sessions will be adapted to the level of the participants.

The focus will be on the individual development of the children, with a training programme which will vary according to the level of the group and the individual.

2) Duty of parents, custodial parent, to be on call

At the time of enrolment, the parents, foster parent or guardian must provide an address and telephone number where they can be contacted at all times in order to be called if necessary for any communication and/or to obtain an urgent decision or authorisation, including those of a medical nature.

In the event of proven unavailability, the decisions taken by the "Organising Club" shall in any case be considered valid, and any payments that may have been made pursuant to that decision shall also be recognised.

If the minor, due to illness or physical impediment, requires special care or assistance, his or her parents or guardians must expressly indicate this at the time of enrolment, enclosing the health form provided in Article 6) below with all the necessary instructions and the contact details of the attending physician.

3) Required medical certificates

By the beginning of the Summer Camp, the following documents must be provided for each regularly enrolled participant:

- photocopy of the valid certificate of fitness for non-competitive sporting activity (or competitive, for those over 12 years of age) for the duration of the camp.



If these documents are not handed over, the child will not be allowed to start training. These documents cannot be replaced.

For international participants, the 'Organising Club' will assist in booking an appointment for a sports medical examination required in Italy. The 'Organising Club' will send all this information to international participants.

4) Departure and return

The accompanying persons from the "Organising Club" will collect the participants at the time indicated on the registration form. From that moment on, the "Organising Club" will assume responsibility for the minors.

The accompanying persons of the "Organising Club", at the end of the training sessions, will entrust the participants to their respective relatives (the parent or another person if provided with a proxy and a photocopy of the document of the exercisers of parental authority) and from that moment all responsibility of the "Organising Club" towards minors will cease.

5) Variations

Should it not be possible to hold the Summer Camp due to force majeure, the "Organising Club" reserves the right to retain only the costs actually incurred and documented (insurance, booking deposit, t-shirt etc.).

6) Waivers of

In the event of cancellation of participation in the Summer Camp, which must be received exclusively by e-mail to summercamp@sienafootballclub.com, participants will be refunded 50 % of the participation fee.

7) Return

A participant who, for whatever reason, requests early withdrawal from the Summer Camp will not be entitled to a refund for the period not taken, and the costs of the withdrawal will be borne by the participant.

8) Refund



No refund will be given to those who do not show up on the day of the Summer Camp without prior notification. No refund will be given to those who are unable to attend the Summer Camp due to the lack or inaccuracy of the required personal documents (medical certificates, health card, full payment of deposit and participation). No refund will be given to any participant who is dismissed as a result of violating even a single clause of these regulations.

9) Exemption from liability

The "Organising Club" is not liable for any documents, money or valuables forgotten, lost or stolen during the participants' stay at the Summer Camp.

10) Complaints

Any shortcomings occurring during the Summer Camp must be reported by the participant to the on-site staff without delay so that the "Organising Club" can remedy them promptly.

The participant may also reiterate the complaint by sending a registered letter with acknowledgement of receipt no later than 10 working days after the end of the Summer Camp.

11) Participant behaviour

If the participant engages in behaviour seriously contrary to the normal rules of fairness and civilisation, the "Organising Club" reserves the right to warn the family and to terminate the contract by having the participant return at the participant's expense.

Participants will be held liable for any damage caused by their bad behaviour.

In the event of force majeure, the "Organising Club" reserves the right to make any changes to these regulations.

In the event of a legal dispute between the parties on the interpretation of this contract or part of it, the competent court shall be Siena.

12) Data processing

Pursuant to and for the purposes of Legislative Decree 196/2003, the "Organising Club" shall process the personal data provided during the stipulation and/or execution of the contract for purposes strictly connected with and instrumental to the management of customer relations (e.g. acquisition of information prior to the conclusion of contracts,



execution of operations based on the obligations arising from the contract concluded with the customer).

In relation to the aforementioned purposes, the processing of personal data is carried out using manual, IT and telematic tools with logics strictly related to these purposes and, in any case, in such a way as to guarantee the security of the data.

Personal data may be provided, within the framework of the contractual relationship and without the need for the consent of the participant and/or the exercising parental authority, to medical facilities, Public Safety facilities, and the sports facilities chosen to hold the Summer Camp.

Pursuant to Article 17 of Legislative Decree 196/03, citizens may exercise the following specific rights: the data subject may obtain confirmation from the data controller as to whether or not personal data concerning him/her exist and that such data be made available to him/her in an intelligible form. The interested party may also ask to know the origin of the data as well as the logic and purposes on which the processing is based; to obtain the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, as well as the updating, rectification or, if there is interest, the integration of data; to oppose, for legitimate reasons, the processing itself.

The data controller of the personal data collected in execution of the contract is Siena F.C. Viale dei Mille, no. 3 in Siena.
